Festivals Fredonia, Inc. reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.**

**You must provide your own tables, chairs and tents; you will be situated within Barker Commons, in conjunction with the Fredonia Farmers' Market on the West side of the Commons.**
