Vendors agree to be present and available from 12 noon until 7 PM on Saturday, June 26, 2021, to sell their handmade/homemade products, crafts, art works to the public as described below, **preferably Italian-themed products**. Homemade food items will NOT be permitted for sale at this venue under this contract. Vendors that wish to participate must have a valid copy of their NYS Sales tax permit with them and a copy of their liability insurance the day of the event and be able to present it if asked by a member of the Fredonia Italian Festival Committee or a Federal/State Government Agency. Vendors will be located in Barker Commons Park and will be responsible for maintaining sanitary conditions of their space and removal of waste before leaving. All vendors will be responsible to return their area to original condition. Vendors will be required to provide their own tables, chairs and tents as needed for use at this event. Vendors are expected to treat customers in a courteous manner. Discrimination of any kind for any reason is NOT permitted. The Village of Fredonia reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.

**Craft / Artist Vendor Display Booth Description:**

In order to evenly distribute the placement of booths in the Barker Commons Park, we must have an accurate description of what you will be selling, displaying and the manner in which you will display your materials.
