Vendors will be responsible for maintaining sanitary conditions of their space and removal of waste/trash before leaving. Vendors will be responsible to return their area to original condition. Vendors are expected to treat customers in a courteous manner. Discrimination of any kind for any reason is NOT permitted. Festivals Fredonia, Inc. reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.
