Winery agrees to be present and available from 11 AM until 6 PM on Saturday, September 10, 2022, to serve samples of their products and for product sales to persons of legal drinking age. Wineries that wish to participate must have a valid copy of their NYS Sales tax permit along with a copy of their Winery Permit, issued by the NYS Liquor Authority with them the day of the event and be able to present it if asked by a member of the Festivals Fredonia Committee or a Federal/State Government Agency. Winery must provide a valid Certificate of Insurance, naming Festivals Fredonia, Inc. as an additionally insured. Winery vendor is expected to treat customers in a courteous manner. Discrimination of any kind for any reason is NOT permitted. Festivals Fredonia, Inc. reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.

You must provide your own tables, chairs and tents; you will be situated within Barker Commons, along with the Fredonia Farmers' Market, on the West side of the Commons.

It is mutually understood and agreed that the above named stands in relationship of an independent contractor to, and is not an employee or agent of the Committee or Festival in question. They shall indemnify and hold Festivals Fredonia, Inc. the Board Members /Team/Committee/Festival and the Village of Fredonia, its Mayor and Trustees harmless from any liability, claim, demand or judgment arising from the performance of the terms of this agreement.
