

# Fredonia Farm Festival Kids Power Wheels Demo Derby

**Saturday, August 26, 2023 4:00pm**

**Location: Park Street**

**Two Age Groups: Ages 3-5 and 6-11**

Rules:

- Judges can rule that children won't participate if there are modifications to the car more than those allowed that are stated below!
- All drivers must supply their own car and set it up according to the rules.
- When choosing a Power Wheels for your child, please keep in mind these vehicles will be running into each other (like bumper cars or derby cars). The Power Wheels needs to be the kind the child sits IN, not ON. And they need to be seat belted INTO the car. No 4-WHEELERS, TRACTORS, MOTORCYCLES! Must be a vehicle they sit IN, not ON.
- Driver only, NO passengers
- Helmets must be worn (bicycle helmets are permitted)
- Seatbelts are recommended
- The vehicle is allowed to have UP TO a 12-volt lawn mower or motorcycle battery, which cannot be mounted in the passenger seat and battery must be secured and sealed away from the child.
- Derby is limited to 6 to 12-volt power wheels ONLY. No connecting multiple batteries together. (This makes the power wheel move too fast, and makes it unsafe)
- All doors and tailgates must be strapped shut. No sharp edges. Use zip ties or duct tape or other flexible product for making them stay shut.
- Stock Tires Only. Tires may be covered with duct tape to prevent them from cracking or breaking. No screws in tires, no chains, etc.
- Motor must remain stock. The only modification you may use and will be allowed is using a lawn mower or motorcycle battery with inline fuse
- Decorative changes can be made to the Power Wheel to make it look like a derby car, however, there can be no reinforcement to the power wheel. Changes and additions are only decorative-- example: header pipes sticking up, painting the car, etc.
- If a child gets out of the power wheel during the event, that child is out of the event.
- At all times remember that this is for kids! Don't add something that could cause them not to be in the derby. You could have a disappointed child if not allowed to run.
- Driver and 1 Parent/Guardian must attend pre-race meeting which will be at 2:00pm.
- If vehicle has more than one speed, low speed must be used.
- There will be no more than 10 participants in each age group – first 10 to sign up.
- All Power Wheels must be checked in at the "Pit" on Park Street by 3:00pm and then impounded till time of event for precheck.
- Four balloons will be attached by the Festival. The object is to pop the balloons. The last one left with a balloon is the winner.
- All participants will receive a prize and be entered for a chance to win a new Power Wheel.
