Festivals Fredonia, Inc. will promote and advertise the wine/beer/alcohol as part of the **Fredonia Italian Festival** in both print and electronic media forms. Wine/beer/alcohol vendors agree to be present and available from 12 noon until 7 PM on June 20, 2026, to serve samples of their products and for product sales to people of legal drinking age. Vendors who wish to participate must have a valid copy of their NYS Sales tax permit along with a copy of their permit, issued by the NYS Liquor Authority with them the day of the event and be able to present it if asked by a member of the Festivals Fredonia Committee or a Federal/State Government Agency. Vendor must provide a valid Certificate of Insurance, naming Festivals Fredonia, Inc. as an additionally insured. Vendors will be located at the **Fredonia Beaver Club at 64 Prospect St, Fredonia**, and will be responsible for maintaining sanitary conditions of their space and removal of waste before leaving. All vendors will be responsible for returning their area to original condition. Vendors will be required to provide their own tables, chairs and tents as needed for use at this event and are expected to treat customers in a courteous manner. Discrimination of any kind for any reason is NOT permitted. Festivals Fredonia, Inc. reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.

It is mutually understood and agreed that the above-named stands in relationship of an independent contractor to and is not an employee or agent of the Committee or Festival in question. They shall indemnify and hold Festivals Fredonia, Inc. the Board Members /Team/Committee/Festival and the Village of Fredonia, its Mayor and Trustees harmless from any liability, claim, demand or judgment arising from the performance of the terms of this agreement.
