Festivals Fredonia, Inc. will promote and advertise vendors as part of the Harvest Moon Cemetery Tours in both print and electronic media forms. Vendors agree to be present and available from Friday, October 16, 2026 from 6 PM until 11 PM and/or Saturday, October 17, 2026 from 6 PM until 11 PM (or sooner if not busy), to sell their handmade/homemade products, crafts, art works to the public as described below. Please note that resellers of products or services will not be permitted for this event. Homemade food items will also NOT be permitted for sale at this venue under this contract. Vendors that wish to participate must have a valid copy of their NYS Sales tax permit and a copy of their liability insurance with them the day of the event and be able to present it if asked by a member of the Festivals Fredonia Committee or a Federal/State Government Agency. Vendors will be located in Barker Commons Park and will be responsible for maintaining sanitary conditions in their space and removal of waste before leaving. All vendors will be responsible for returning their area to their original condition. Vendors will be required to provide their own tables, chairs and tents as needed for use at this event. Vendors are expected to treat customers in a courteous manner. Discrimination of any kind for any reason is NOT permitted. Festivals Fredonia, Inc. reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.**
